DRIVER OF THE MONTH/YEAR PROGRAM

DRIVER ELIGIBILITY:

- 1) Employer must be a member of the Pennsylvania Motor Truck Association in good standing.
- 2) The nominated driver must reside and/or be domiciled in the Commonwealth of Pennsylvania.
- 3) Drivers can be nominated in subsequent years by filing a new entry provided they continue to be eligible, however, any driver selected as Driver of the Month cannot be nominated the following year but may be nominated thereafter.

NOMINATION:

- 1) Driver of the Month nominations must be submitted on the form provided by the Safety Management Council.
- 2) Nominations may be made by any party, but must be approved by the employer or a representative of the employer.
- 3) An employer may submit as many Driver of the Month nominations as they wish.
- 4) *A photo of the nominated driver must be accompanied with the application form. (hard copies can be mailed, or an email format can be sent to nwilkes@pmta.org).*
- 5) Nominations for Driver of the Month may be mailed to the Pennsylvania Motor Truck Associations Safety Management Council at 910 Linda Lane, Camp Hill, PA. 17011-6409, at any time.
- 6) The Driver of the Year Program runs annually from January to December.
- 7) Driver of the Year will be selected from the twelve drivers of the month. The State driver of the year will be nominated for National Driver of the Year in the American Trucking Associations program.

DOCUMENTATION: In addition to the official entry form, you should attach a letter stating the basis for your nomination outlining the driver's accomplishments. Also attach a current copy (within 30 days) of the driver's M.V.R. driving record report. Letters received by your company on behalf of the driver, a note of letter from the driver or a member of his family, and any other information in support of the driver's nomination may be submitted also.

JUDGING: Final judging and selection is done by the Driver of the Month and Year Selection Committee. Since the committee is not able to interview the nominees, the documentation and support letters carry weight in making their decision.
